The following are the minutes of the Board of Trustees of Passaic County Community College, held via an online Zoom web-based meeting service, on Tuesday, July 21, 2020.

CALL TO ORDER/PLEDGE OF ALLEGIANCE

Vice Chairwoman Tanis called the meeting order at 7:01 p.m., and then asked everyone to join her in the Pledge of Allegiance.

President Rose stated notice of the meeting was emailed to the Herald News, the Record, the Office of the County Clerk, the college community, and posted on the PCCC website on July 15, 2020.

CONSIDERATION OF MINUTES – June 16, 2020

Vice Chairwoman Tanis asked if there were any corrections to the minutes for June 16, 2020. Hearing none, she then asked for motion on Resolution #1 – Consideration of Minutes for the June 16, 2020 board meeting. Trustee Trivedi moved Resolution #1; seconded by Trustee Marco. Upon roll call, Resolution #1 passed with all members present voting "yes."

PRESENTATIONS - Academic Council

President Rose stated that the Passaic County Community College Community was very concerned about the growing instances of violence and injustice against the Black community. Internally there was a consensus that we wanted to do more than just issue a statement of condemnation, but instead look for ways that we can make a positive contribution. For the first time in the history of the College, a special meeting of the Academic Council was called on June

30, 2020 to address the current situation. He then introduced Professor Nina-Louise Alsbrook-Jackson, Associate Professor and Chair of the English and Fine & Performing Arts Department, and President of the Academic Council to present the Council action.

Professor Alsbrook spoke about the outpouring of requests from the College community to address the issue of the disturbing and tragic events taking place currently all over the country and the world toward the Black community, which included violence and senseless deaths. She stated that an emergency meeting of the Academic Council convened on June 30, 2020, and the following resolution was presented, read, adopted, and overwhelmingly approved by the Academic Council. She asked for the Board's indulgence while she read aloud the following resolution:

WHEREAS Passaic County Community College is deeply saddened by the series of disturbing and tragic events that have taken place over the last few weeks related to the violence and injustice toward the Black community, including the senseless deaths of Rayshard Brooks, George Floyd, Breonna Taylor, Ahmaud Arbery, and countless others.

WHEREAS The College does not see these matters as isolated events, but recognizes the systemic structures that foster race based discriminatory practices throughout our society.

WHEREAS Passaic County Community College is seeking to live up to our Mission Statement and Institutional Goals to fulfill our promise to "provide a supportive learning environment for members of the college community" and demonstrate we "value our diversity, because it enriches our learning environment and deepens our respect and appreciation for others."

WHEREAS We recognize we cannot achieve our highest purpose without helping our Black students to navigate any barriers to their pursuit of higher education.

BE IT RESOLVED The Academic Council, as the shared governance body of Passaic County Community College, will help to assess (and improve where necessary) PCCC's institutional approach to identifying, recruiting, educating, and supporting marginalized populations, with special emphasis on Black students and their success within our College Community. Steps to instituting systemic change will include:

- Creating an AdHoc committee to assess the current climate of diversity within various facets of the PCCC College Community.
- Disseminating the findings of that committee to applicable parties on campus to provide guidance for recruitment and retention activities, student programming, and professional development aimed at spurring systemic changes within our institution.
- 3. Fostering a platform at every Academic Council meeting for the committee and its collaborators

to share with the College community the progress being made on any associated endeavors or challenges that must be mitigated for progress to move forward.

Vice Chair Tanis stated that she would like the Board to endorse the Academic Council Resolution, as presented, and asked for a motion. Trustee DuHaime stated his problem with the word "inequality" noting that the College has had more Blacks than at any other time, and would not vote in favor of the Resolution if that word was not changed. Trustee Marco moved the following resolution seconded by Trustee Pou. :

BE IT RESOLVED that the Board of Trustees of Passaic County Community College, upon the recommendation of the President, hereby endorses the Resolution presented and endorsed by the Academic Council of Passaic County Community College, at its emergency meeting held on June 30, 2020.

Upon roll call, the endorsement of the Academic Council Resolution passed with Trustee DuHaime "abstaining" and all other members present voting "yes."

Fall Restart

President Rose updated the Board noting that things in New Jersey were not returning to normal anytime soon. He stated that instruction would be 10% in-person with the other 90% online and/or remote. On a positive note, he stated that the Public Safety Academy in Wayne was fully operational and all safety protocols are being practiced. A Restart Plan was being prepared to provide the community with details of the College's fall plans.

President Rose also noted that a laptop program was being implemented to help ensure that all students and employees have access to appropriate technology. Trustee Pou raised several questions about the purchase of the laptops. There was discussion of how K-12 differs from higher education.

REPORTS

<u>President</u>: President Rose gave an update to the status of what to expect in higher education this coming fall with guidelines provided by the Office of the Secretary of Higher Education. Room formats, allowable capacity, social distancing are all playing a role with the restart of on-campus instruction. Details continue to change almost daily.

President Rose gave Sandy best wishes from the College upon his retirement.
