#### **CONSIDERATION OF MINUTES** – May 18, 2021

Chairman Marco asked if there were any corrections to the minutes for May 18, 2021. Hearing none, Trustee Nutter moved Resolution #1 – Consideration of Minutes for the May 18, 2021 board meeting; seconded by Trustee Pou. Upon roll call, Resolution #1 passed with Trustee Montanez-Diodonet "abstaining" and all other members present voting "yes."

#### **PRESENTATION**

#### Continuing Education and Workforce Development

Prior to the presentation starting, President Rose had both the new trustees, Sandra Montanez-Diodonet, Michael Glovin, and Alumni Representative Sony Ballem, introduce themselves since this was the first in-person meeting in over a year. President Rose then introduced Ms. Janet Albrecht, Executive Director of Continuing Education and Workforce Development to give that evening's presentation. He prefaced his introduction by noting that that area of the College was one of the fastest growing with its programs, and the incredible job Ms. Albrecht does in running its programs, including the Public Safety Academy.

Ms. Albrecht began her presentation noting that her department was indeed a very large one and operated on all four campuses. She listed some of the programs being offered, which included EMT, ELS, Welding, and Medical Technician, to name a few. Through a PowerPoint presentation, she highlighted and focused on key programs that she and her to provide during the year of COVID, 2020. She noted that while many of the departments worked remotely, her division did not have that luxury and returned to the in-person instruction in July of 2020. The programs she highlighted were MRI/Mammography, Fire Science, Welding in partnership with Passaic County Technical Institute, as well as a dual enrollment agreement for EMT.

Trustee Pou left the room at 7:21 pm.

Ms. Albrecht then turned her attention to Workforce Development and the collaboration between many entities the College works with, one of which was the One Stop that was located in one of the College's building on the main campus. Other initiatives included working with St. Joesph's Hospital, Calvary Baptist Church, and St. Paul's Church to help assist them in finding new employment and/or refining their skills for individuals. Grants help fund these projects.

A brief question and answer took place after the presentation.

President Rose publicly thanked Trustee Nutter for his role in having the national GPOIC provide partnerships with community colleges around the country via OIC of America.

Ms. Albrecht thanked the board for the opportunity to present before the board.

#### REPORTS

Statement of Revenue and Expenditures

<u>President</u>: President Rose reported on the Statement of Revenue and Expenditures noting once again that this year has been like no other, and due to additional funding by the federal and state governments, the College was doing well this year despite the drop in enrollment. He also noted that Mr. Steven Hardy, Vice President for Finance and Administrative Services, was trying his best to keep abreast of the constant changes to use the money given to the College.

The only change he did note was the clinical fee being charged to all new, incoming students in the Nurse Education Program, which was in line what other colleges were also doing.
