The following are the minutes of the Board of Trustees of Passaic County Community College, held via an online Zoom web-based meeting service, on Tuesday, June 16, 2020.

CALL TO ORDER/PLEDGE OF ALLEGIANCE

Chairman Nutter called the meeting order at 7:00 p.m., then asked everyone to join him in the Pledge of Allegiance.

President Rose stated notice of the meeting was emailed to the Herald News, the Record, the Office of the County Clerk, the college community, and posted on the PCCC website on June 9, 2020.

CONSIDERATION OF MINUTES – May 19, 2020

Chairman Nutter asked if there were any corrections to the minutes for May 19, 2020. Hearing none, he then asked for motion on Resolution #1 – Consideration of Minutes for the May 19. 2020 board meeting. Trustee Marco moved Resolution #1; seconded by Trustee Pou. Upon roll call, Resolution #1 passed with all members present voting "yes."

PRESENTATION – STUDENT GOVERNMENT ASSOCIATION (SGA)

President Rose stated that he never met a better group of students than the group they had this year, and noted that when they all start in the Student Government Association, they are all very quiet and shy. He confirmed that with both Dr. Sharon Goldstein, Dean of Student Affairs and Services, and Ms. Maria Marte, Director of Student Activities. He also added that through their presentation, all would see how they have learned with events that would last them throughout their lifetimes.

The students introduced themselves and presented a PowerPoint presentation highlighting their activities for the academic year. Some of those topics presented were "Green Initiatives (new

water dispenser, urban agricultural initiatives, and climate change); the SGA Retreat and Planning Committee; and the Statewide Community College SGA Leader Coalition, to name a few. Each member of the Executive Board spoke throughout the presentation: Maya Abaza, President; Robby Rosa, Vice President; Demi Matos, Treasurer; and Pauleen Coronel, Secretary.

President Rose thanked them once again for a job well done. He also informed the students that he would find a date that would work to invite them to the annual picnic he hosts every year.

REPORTS

<u>President</u>: President Rose gave an update to the status of what to expect in higher education this coming fall with guidelines provided by the Office of the Secretary of Higher Education. Room formats, allowable capacity, social distancing are all playing a role with the restart of on-campus instruction. Details continue to change almost daily.

President Rose did state some great news and that was enrollment was up this summer and that was with both online and remote learning. He did say, however, that the State of New Jersey still has a financial crisis and moved its end of fiscal year date to September 30 from June 30. The shortfall in revenue was due to less state income taxes because of the pandemic since it affected so much in the state. He stated he would defer to Trustee Marco who would have more information on that topic.

Trustee Marco, who represents the board at the New Jersey Council of County Colleges, informed the board that the financial crisis was a hardship for all, especially community colleges. The current proposal is a 100 percent cut in funding for July, August and September. He noted that the NJCCC Legislative and Policy Committee put together an Advocacy Campaign to reach out to the legislature to help address that dire situation since community colleges lead in helping rebuild the economy.

Trustee Marco stated that each member of the Board, after the meeting, needed to send a personal email to each of the legislators in each respective district. He would send each a draft to use to send out.

President Rose stated that times are not normal. There are budget issues as well as cash flow issues. He recently met with all three unions to discuss a delay to their raises until January, which all agreed. Vacant positions remain unfilled, and the discussion of furloughs and layoffs was something that still may need to be addressed.

He ended with saying that he tried to talk her out of leaving, but her mind was made up.

Ms. Michelle Softley, Director, Educational Opportunity Fund

President Rose joked that Ms. Softly started working at the College when she was only a child, and after 40 years, she was the program leader in the State of New Jersey who has developed and mentored numerous people. In fact, she was the one responsible for making PCCC's EOF Program a model for the State. President Rose also stated that Ms. Softley had a stroke that past week but was informed she would be fine.

President Rose wished both women best wishes from the College upon their retirement.
