The following are the minutes of the Board of Trustees of Passaic County Community College, One College Boulevard, Paterson, New Jersey, held on Tuesday, April 17, 2018.

CALL TO ORDER

President Rose stated that notice of the meeting was mailed to the Herald News, the Record, the Office of the County Clerk, and posted on the bulletin board of the College Boulevard building on November 20, 2017.

Chairman Nutter stated that inasmuch as adequate notice of the meeting had been given, the meeting was called to order at 7:03 p.m. A copy of the agenda was reviewed and available for public inspection.

CONSIDERATION OF MINUTES – March 13, 2018

Chairman Nutter asked for a motion on Resolution #1 – Consideration of Minutes for March 13, 2018; moved by Trustee Moody; seconded by Trustee Tanis. Upon roll call, Resolution #1 passed with all members present voting "yes."

PRESENTATIONS

Men of Color Success Initiative

The *Men of Color Success Initiative*, as presented by Mr. William Morrison, Associate Dean of Academic Affairs; and Professor James T. Sanders, III, Instructor in the English/Public Speaking Department, centered on male students who are at risk. In a joint PowerPoint presentation, the areas covered by both professionals included academic support, critical mentoring, life changing experiences, career advice, financial literacy, health and wellness activities, and engaging with good role models from similar backgrounds.

The Core Group for this initiative was comprised of both faculty and administrators on campus, with meetings being held every Thursday for one hour. Three students were able to share their observations that evening with the Board, as well as the positive experience each has received so far. The students presenting that evening were Mr. Tyrell Wright, Mr. Marvin Espana, and Mr. Andrew Brier. Professor Sanders noted that the mentors involved with the program explain to the students the value in becoming responsible, professional men.

A brief question and answer session then took place.

Middle States PTK Regional President

Professor Jennifer Gasparino, Instructor in the Human Services Department and PTK Advisor, spoke briefly on Phi Theta Kappa (PTK), the chapters and the divisions. She explained the College was in the Middle States division and was so excited to announce that Ms. Jennifer Greco, a member of PTK, was recently elected as the new Middle States Regional President, who would serve as president for the 2018/2019 academic year. Professor Gasparino noted that the College has never had representation like that in the 36 years of the chapter's existence, and that the competition was fierce with two other challengers.

Ms. Greco explained the process and the support the College provides, thanking the PCCC Foundation, Ms. Meredith Behrens and Mr. Page Saunders from the Office of Institutional Advancement, for their marketing efforts and vision. She also thanked Professor Alex Della Ferra for sitting with her and going over drafts of her speech, which had to stay to three minutes. (Ms. Greco's speech finished at two minutes fifty-nine seconds.) She then thanked Professor James Sanders, emphasizing how he worked with her on how to speak with others, set responsibilities, and to have goals. She then presented him with the t-shirt worn at the convention. Professor Gasparino informed everyone that the speech could not be about why they wanted to be president; it had to be on an honor study topic requiring research.

Ms. Greco stated her topic was about transformation, acknowledging, effecting and achieving change, and played the video of her speech, as well as her receiving the honor of being elected as the new Middle States Regional President.

President Rose spoke about the annual Fact Book provided by the New Jersey Council of County Colleges, which provides demographic and other data on various community colleges in the state.

Significant Activities

President Rose reminded everyone about two important events that were coming up, with the first being the Salem Biz Breakfast on April 19, 2018 at the Wanaque Academic Center. Trustee DuHaime noted that AM970 enjoyed doing its radio show at Wanaque in October that they wanted to come back again. Along with Mr. Joe Piscopo, the lineup for panel discussion included Mr. Bernie Kerik and Assemblyman John Bramnick, to name a few. Mr. Steve Adubato would once again be the moderator.

The second event was the PCCC Foundation's Annual 26th Gala on April 26, 2018, being held at the Hamilton Club building. The honoree this year was Mr. David Daly of PSE&G, along with the first-time outstanding Alumni, Ms. Olga Y. Garcia.

President Rose stated that he hoped everyone would be able to attend one, if not both, events.

President Rose stated that the New Jersey Department of Education requires Board action on any changes and/or amendments to its original budget submission, with the latest amendment of \$39,584 being reallocated in order to spend the entire allocation given to the College.

The grant application presented was to the New Jersey State Council on the Arts for the Local Arts Program for the period January 1 to December 31, 2019, with this being the first of a three-year grant.
