President Rose stated that notice of the meeting was mailed to the Herald News, the Record, the Office of the County Clerk, and posted on the bulletin board of the College Boulevard building on July 2, 2018.

CONSIDERATION OF MINUTES – June 19, 2018

Chairman Nutter asked for a motion on Resolution #1 – Consideration of Minutes for June 19, 2018; moved by Trustee Ciambrone; seconded by Trustee Tanis. Upon roll call, Resolution #1 passed with Trustees Kebrdle, Marco and Trivedi "abstaining" and all other members present voting "yes."

PRESENTATION

"Blockchain: A Use Case Analysis"

Dr. Jacqueline Kineavy, Senior Vice President for Academic and Student Affairs, introduced Professor Marc Yeung, an Instructor in the Mathematics Department, and former

chairperson of the Honors Program at the College, to present, along with one of his students, the winning proposal given at the Beacon Conference held at Montgomery Community College.

Professor Yeung began his presentation by listing the categories involved in that conference and how it narrowed down to just three submissions – with his student, Mr. Maximino (Max) DiGiacomo-Castillo being one of them. Professor Yeung stated that Max presented his theory on Blockchain and won first place in Computer Science. He then turned the presentation over to him.

Max then gave his presentation and spoke about the impact technology has had on many different things, highlighting the Super Nova in 1996 to the Internet, and how Blockchain was one form being used by many large companies today. He went on to further state how a company and/or person using Blockchain would be able to see where every dollar goes within seconds. Max mentioned he was a Lakeland High School Graduate with a 4.0 GPA; Computer Science was his major. He stated he would like to continue his research at a four year school, and Professor Yeung encouraged him and supported him as well in that endeavor.

Proposed-Revised Fiscal Year 2019 Operating Budget

President Rose presented the Proposed-Revised Fiscal Year 2018-2019 Operating Budget noting the minor revisions from the budget approved in January. He also elaborated on the Governor's Free Community College Tuition plan that was approved with the state budget. He noted that that was the most significant item in the State Budget, with \$25 million dollars set aside for that initiative, \$5 million dollars of which would be start-up money for community colleges, and the remaining \$20 million dollars going toward tuition for a student to attend a community college.

FIRST READING: D104 - BASIC SKILLS TESTING PLACEMENT

President Rose provided the background and current practice at PCCC, and most colleges, of how students entering college were given a nationally recognized placement exam to determine the initial placement of students. Through research, colleges have found that utilizing "multiple measures" for placement would be more accurate in determining the students' initial placement. Multiple measures would include: high school transcripts, grade point average, honors courses, and if a student has college credits already, in addition to placement scores.

A brief question and answer session took place with Trustee Ciambrone recommending to change the wording from "Test or" to "Test and/or".
