The following are the minutes of the Board of Trustees of Passaic County Community College, held at the Wanaque Academic Center, Room W125, 500 Union Avenue, Wanaque, New Jersey, on Tuesday, July 16, 2019.

CALL TO ORDER

President Rose stated that notice of the meeting was mailed to the Herald News, the Record, the Office of the County Clerk, and posted on the bulletin board of the College Boulevard building on November 14, 2018.

Chairman Nutter stated that inasmuch as adequate notice of the meeting had been given, the meeting was called to order at 7:08 p.m. A copy of the agenda was reviewed and available for public inspection.

CONSIDERATION OF MINUTES – June 18, 2019

Chairman Nutter asked for a motion on Resolution #1 – Consideration of Minutes for June 18, 2019; moved by Trustee Moody; seconded by Trustee Marco. Upon roll call, Resolution #1 passed with Trustees Moody, Pou, and Rodriguez "abstaining" and all other members present voting "yes."

PRESENTATIONS

PCCC Culinary Arts Baking Program

Chef Louis Hernandez, Director of the PCCC Culinary Arts Program located at the Wanaque Academic Center, presented an overview of the PCCC Culinary Arts Baking Program.

Through a PowerPoint presentation, Chef Hernandez explained the concept behind the program's stackable credentials, pointed our specific courses such as ServSafe, which was part of the *National Restaurant Association Certification*. He also noted students have the ability to earn multiple certificates while working toward their A.A.S. degree.

Trustee Esquiche left the room at 7:15 p.m. and returned at 7:16 p.m.

Chef Hernandez continued his presentation by providing detailed information on specific courses while noting students are able to apply for gainful employment after taking four specific courses in the program. The stackable credentials were as follows:

Certificate of Achievement in Baking
Career Certificate in Baking
Associate of Applied Science in Pastry and Baking

Chef Hernandez closed his presentation by informing everyone that an evening program in Culinary Arts would start in Fall 2019. Students are responsible to buy their own uniforms, shoes, and knives from the PCCC Bookstore, with the knives being the most expensive item at \$350-\$600.

A brief question and answer took place with Chef Hernandez encouraging the Board to call him at any time and he would be happy to speak to them. He was then thanked for his presentation and the delicious dinner and desserts provided that evening.

Rifle Camp Park Project

President Rose gave an overview of the development of the Environmental Center at Rifle Camp Park. He then introduced Mr. Steve Coppa, Architect, of the firm Coppa Montabano, who is developing the plans for the project.

Mr. Coppa, through a PowerPoint presentation, provided an updated preview of the Rifle Camp Park Project, noting that the building would function as a multi-purpose building wherein public meetings could be held (the County and the College for example), with large, flexible space for various events, and smaller space for labs, to name a few.

A partner in that venture was PSE&G.. The project should commence in early 2020 after the funding was bonded. All were amazed at the incredible view from the observatory, and the fact that four to five meetings could take place all at the same time.

REPORTS

<u>President</u>: President Rose elaborated on the wild budget sessions that recently took place noting it was unlike any other. President Rose was pleased as well to announce that community

colleges did well in the budget by continuing the CCOG program with the income eligibility raised to \$65,000 for an individual. Some program fees would not be covered due to the high costs, such as Nurse Education and Culinary Arts. All in all, he stated it was a definite "win-win" for community college students.

PCCC 2019 Fact Book

President Rose stated that the PCCC 2019 Fact Book was full of useful information that he felt was very insightful. He also noted that that data was the one used when the College does its reporting to the state and federal agencies.

News Articles

President Rose gave highlights of the news articles in the packet, which dealt with the free CCOG, the Annual Poetry Contest with the area's public schools and headed by the Cultural Affairs and Poetry Center departments.

Trustee Trivedi returned to the PCCC 2019 Fact Book asking questions about the Culinary Arts Program, as it pertained to jobs and hourly wages. Trustee Smith referenced statistics provided on page 62 noting the numbers speak for themselves overtime.

President Rose took a moment to thank Alumni Representative Alex Medina for his service to the Board over the last year as its alumni representative of the 2018 graduating class. Mr. Medina stated it was a great educational experience for him and a pleasure to be a part of the Board of Trustees.

President Rose stated he would be happy to answer any questions about his other activities.

A. ACADEMIC ITEMS

From the New Jersey State Council on the Arts/Department of State:

Co-sponsored Project Grant for the period July 1, 2019 – June 30, 2020 in the amount of \$30,000. The funds will be used for fieldwork, folk arts programming, publications, and special projects, and a portion of the grant will be used toward part-time salary. The Hamilton Club will serve as the home for folk arts exhibits. This is the 2nd year that this grant has been awarded.

The Local Arts Program Grant for the period January 1, 2020 to December 31, 2020 in the amount of \$102,875. The PCCHC will administer these funds by re-granting them to non-profit and government organizations producing arts and cultural programs in Passaic County. A portion of the grant is used toward part-time salary and for special projects benefitting regrantees and the community. This is the 40th year that this grant has been awarded.

Poetry Center General Project Support Grant for the period July 1, 2019 to June 30, 2020 in the amount of \$19,373. The Poetry Center will use these funds to present a variety of programs, including poetry workshops, readings, publications, contests and awards. This is the

40th year that this grant has been awarded.

Theater and Poetry Project (TAPP) General Project Support Grant for the period July 1, 2019 to June 30, 2020 in the amount of \$7,810. TAPP is a Language Arts enrichment partnership, which presents high quality children's theater, music and dance programs, and poetry workshops to Paterson students. This is the 29th year that this grant has been awarded.

From the New Jersey Historical Commission/Department of State:

County Historic Partnership Program Grant for the period January 1, 2020 to December 31, 2020 in the amount of \$18,450. F103 CHILDREN ON CAMPUS POLICY

8

Children shall not be brought onto the grounds of the College unless they are participating in special activities or courses sponsored by the College. Children may not attend classes with their parent or guardian. Children may not be left unattended in any College facility at any time nor left with any staff or faculty member. At no time are children allowed in labs, construction/repair sites, or other areas where potential hazards exist. There may be occasions when brief visits to the College by children of students may be appropriate. Children may visit College offices and facilities, other than classrooms and lab, when accompanied by their parent or guardian for limited periods of time when their parent or guardian is conducting routine business at the College.

In the event a child is found to be unsupervised on college grounds, the College will attempt to contact the child's parents or guardians. In the event that the College is unable to contact the child's parents or guardians, then the College will contact law enforcement.

Employees are prohibited from bringing children to the College during the employee's scheduled work hours.

Any student infraction of this policy shall be reported to the Dean of Student Affairs and Services for discipline in accordance with the Student Code of Conduct.

Employees who violate this policy may be directed to leave work to attend to their children and shall be subject to discipline in accordance with current policies.

For purposes of this policy, children are defined as individual under the age of 16.
