The following are the minutes of the Board of Trustees of Passaic County Community College, One College Boulevard, Paterson, NJ held on Tuesday, March 15, 2022.

CALL TO ORDER/PLEDGE OF ALLEGIANCE

Chairman Marco called the meeting to order at 6:00 p.m., and then asked everyone to join him in the Pledge of Allegiance.

President Rose stated pursuant to the Open Public Meetings Act, notice of this meeting was emailed to the Herald News, The Record, the Office of the County Clerk, and posted on the PCCC Website and bulletin board on November 17, 2021.

CONSIDERATION OF MINUTES – February 15, 2022

Chairman Marco asked if there were any corrections to the minutes for February 15, 2022. Hearing none, Trustee Moody moved Resolution #1 – Consideration of Minutes for the February 15, 2022 board meeting; seconded by Trustee Pou. Upon roll call, Resolution #1 passed with Trustee Smith "abstaining" and all other members present voting "yes."

<u>PRESENTATION</u> – Middle States Commission on Higher Education Standards for Accreditation and Requirements for Affiliation

President Rose gave the background information how Passaic County Community College was accredited by the Middle States Commission on Higher Education (MSCHE), noting that accreditation was necessary for students to be able to receive financial aid. In addition, he stated that most colleges would only recognize academic credits from accredited institutions. Every eight years all colleges and universities accredited by Middle States go through a "self-study" process with the intent leading to the reaffirmation of accreditation. Each board

member received a copy of the *Middle States Standards for Accreditation and Requirements of Affiliation* in their packets. President Rose then stated that PCCC was beginning its self-study process this spring, with a planned team visit from Middle States in spring 2024. He then introduced the co-chairs overseeing that process, which included Dr. Christine Redman-Waldeyer, Professor; Dr. Dawn Norman, Associate Dean; Dr. Justin Hull, Executive Director; and Ms. Meredith Behrens, Communications.

Each co-chair then went through the steps and processes of the self-study emphasizing their role and which Standards they were responsible for, noting that there are seven Standards in all, with well over 100 faculty and administrators involved in that process with preparations geared up for the site visit in 2024.

<u>REPORTS</u>

<u>President</u>: President Rose reported that the federal government approved a no-cost extension to spend the HERFF Funds that were granted to the College. This will provide much needed flexibility.

<u>Chair:</u> No oral report was given at this time, but next month an update on some legislative issues affecting community colleges would be presented.
